Fox Locks 2018 Lockage Fees and Operations Schedule

Locks open the weekend before Memorial Day and close the first Sunday of October
(Friday 10am May 18, 2018 through midnight Sunday October 7, 2018)

- Menasha Lock
 - Closed until further notice

- Appleton Locks 1,2,3,4
 - Friday, Saturday and Sunday (including Holidays) 11a-9p
 - Locks are operated on the hour

- Cedars Lock
 - Saturday and Sunday (including holidays) 11a-9p

- Little Chute Lock 2
 - Saturday and Sunday (including holidays) 11a-9p

- Combined Locks
 - Saturday and Sunday (including holidays) 11a-9p

- Kaukauna Locks 1,2,3,4,5
 - Closed until further notice

- Rapid Croche Lock
 - Closed until further notice

- Little Kaukauna Lock (Little Rapids)
 - Monday, Tuesday, Wednesday, Thursday, Friday, Saturday and Sunday 10a-10p
 - Fourth of July open until midnight

- De Pere Lock
 - Monday, Tuesday, Wednesday, Thursday 10a-10p
 - Friday, Saturday and Sunday open until midnight (including holidays)

2018 Fox Locks Fee Schedule

- Season Pass - \$100
 - A permanently affixed season pass is valid all season at all open locks on the Fox River for motorboats and non-motorized boats
 - [http://docs.legis.wisconsin.gov/document/statutes/30.50\(6\)](http://docs.legis.wisconsin.gov/document/statutes/30.50(6))
 - "Motorboat" means any boat equipped with propulsion machinery, whether or not the machinery is the principal source of propulsion.
 - [http://docs.legis.wisconsin.gov/document/statutes/30.50\(7\)](http://docs.legis.wisconsin.gov/document/statutes/30.50(7))
 - "Non-motorized boat" means a boat which is not a motorboat but which is designed and constructed to be used as a boat for transportation of a person or persons on water. This term includes, but is not limited to, any canoe, sailboat, inflatable boat or similar device, row boat, raft and dinghy which is not a motorboat.

- Day pass \$10 Recreational
 - A daily pass is valid for one day at open locks on the Fox River for motorboats and non-motorized boats

- Commercial Vessels \$80 per lockage
 - [http://docs.legis.wisconsin.gov/document/statutes/30.50\(3d\)](http://docs.legis.wisconsin.gov/document/statutes/30.50(3d))
 - "Commercial motorboat" means a motorboat while it is being operated to transport property or passengers for hire or while it is being used by its operator or owner to earn a livelihood or to gain a profit or both.
 - Tour Boat \$80 Round trip down and back
 - Trip 1 De Pere and Little Kaukauna
 - Trip 2 Combined, Little Chute and Cedars
 - Trip 3 Appleton Locks 1,2,3,4

- Scheduled Paddle Events
 - \$1.00 each with a minimum of 100 participants per lockage
 - "Scheduled Paddle Events" are publicly advertised at least one month prior to the event in local newspapers and other media outlets

- Special Lockages after hours and off season (require 24 hour notice)
 - \$50 per lockage for Motorized and Non-motorized boats
 - \$150 per lockage for Commercial Vessels except Tour Boats
 - \$150 Round Trip Little Chute and Appleton Locks for all Tour Boats
 - Less than 24 hour notice will be an additional \$25
